- 1. Apologies were received from Cllr J Hunt & Cllr J Daulby and approved by Council.

- 3. **Minutes** of the meeting held on the 12 September 2023 of the council were approved as accurate and signed by the Chairperson.

4. Reports

4.1 County Councillor N Dixon reported. 1 He wished to reflect on the meeting of 4 October -Safety Report A149/A1551. In summary the proposals should be accepted but include the considerable shortcomings that did not deal with the hazards and hotspots. Some of the evidence was questionable and therefore the credibility has become an issue. 2. The County Deal- devolving some responsibility and funding to a County Level and changing governance that would require the Leader to be elected by the whole electorate and not the lead party. The proposal is for an election to take place in May 2024. This in ClIr ND unlikely May 2025 with the County Council elections would be better suited. ClIr ND remains open minded about this deal which £20 million a year for 30 years to fund areas such as Adult Education. It also means funds will be available automatically in areas we have had to compete.

5. Public Participation Session

Members of the public and email correspondence brought to the council's attention about the recent problems at the Staithe. 1. Live-aboards on BA free moorings. The Chairperson advised the public she had been constant contact with the Broads Authority Ranger whilst they carried out several things to resolve the situation. Yet none have been successful to date. There had been an impact on the Staithe and the council had initiated work to fence of the waste and parking area. Initially this was to just combat fly tipping however vans have been seen to damage the fencing. 2. There has been sightings of two men with suitcases at the Staithe and in the Village. It has been their lack of purpose or seen activity that has caused concern. LN to advise local PC. 3. The Public asked the current position with Mr Slater and the Gravel Hole. The Chairperson advised that we were awaiting a proposal from the landowner. When this was available the village would be made aware and consultation with the village would be undertaken.
